General Release of Liability

READ CAREFULLY - THIS IS A RELEASE AND INDEMNITY AGREEMENT

To the Golden Gate Railroad Museum, Inc., the Pacific Locomotive Association, Alameda County and each of your officers, agents, employees, members and volunteers:

In consideration of being permitted to enter onto or use the Pacific Locomotive Association, Inc. premises at Niles Canyon or to participate in operations, restoration work or other activities of either the Pacific Locomotive Association or Golden Gate Railroad Museum, Inc., at or away from the premises, I hereby release and discharge the Pacific Locomotive Association Inc., Alameda County, Golden Gate Railroad Museum, Inc. and their respective officers, agents, employees, members and volunteers, individually and collectively, from any liability and all claims for damages of any kind or character, known or unknown, fixed or contingent, which I, my heirs or survivors may have now or may arise at any time in the future by reason of my injury, illness, death or damage to property caused by or arising out of any activity related to the Pacific Locomotive Association, Inc., its Niles Canyon Railway, the Golden Gate Railroad Museum, Inc. or related equipment, facilities or activities. Further, I promise to hold each of you harmless from any such claim made on my behalf or by or on behalf of any minor child in my custody or under my control arising out of any injury to the child at or around the premises.

I voluntarily accept the risks and dangers of participating in activities on or about the railroad and related facilities or activities. Not all of the risks and hazards are known but they include, for example, movement and handling of heavy equipment and materials, unexpected movement of rail equipment, grade crossings, dangerous footing, derailment, explosion, escaping steam, toxic and hazardous materials, old equipment and inexperienced personnel.

This release will remain in effect until revoked in writing and delivered to both an officer of the Pacific Locomotive Association, Inc. and to an officer of Golden Gate Railroad Museum.
